



Bylaw #2/05

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR APPLYING MILL RATE FACTORS TO THE SCHOOL MILL RATE


The Council of the RM of Meadow Lake #588, in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Meadow Lake #588 is hereby authorized to enter into an agreement with the Meadow Lake School Division #66 and the Battleford School Division #118 the terms of which are attached hereto and marked Exhibit "A" for purpose of applying the municipal mill rate factors to the school mill rate.
2. The Reeve and Administrator of the Rural Municipality of Meadow Lake #588 are hereby authorized to sign and execute the agreement, the terms of which are set out in Exhibit "A" attached hereto and forming a part of this bylaw.
3. Bylaw #8/01 is hereby repealed.

Schedule "A" to Bylaw #2/05
Rural Municipality of Meadow Lake #588

This AGREEMENT made this 16th day of February 2005

BETWEEN:

The Rural Municipality of Meadow Lake #588 a body corporate under the laws of the Province of Saskatchewan, hereinafter called the "Municipality".

OF THE FIRST PART

and -

The Meadow Lake School Division #66 in the Town of Meadow Lake in the Province of Saskatchewan and the Battleford School Division #118 in the City of North Battleford in the Province of Saskatchewan, as represented by their boards, hereinafter called the "Board".

OF THE SECOND PART

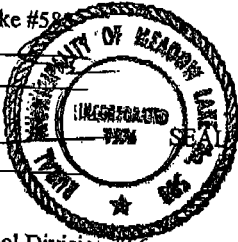
The aforementioned parties agree that:

1. A mill rate factor of 1.0000 shall be applied to the Meadow Lake School Division #66 and the Battleford School Division #118 uniform mill rate for all commercial classes of property in the RM of Meadow Lake #588
2. A mill rate factor of 0.8200 shall be applied to the Meadow Lake School Division #66 and the Battleford School Division #118 uniform mill rate for all residential classes of property in the RM of Meadow Lake #588.
3. A mill rate factor of 0.9319 shall be applied to the Meadow Lake School Division #66 and the Battleford School Division #118 uniform mill rate for all agricultural classes of property in the RM of Meadow Lake #588.
4. In accordance with Section 330.3(6) of The Rural Municipality Act, 1989 the same total amount of tax shall be levied on behalf of the Meadow Lake School Division #66 and the Battleford School Division #118 after the apply of the mill rate factors.
